During our spring 2010 Season, Rio Valley teams register in STYSA Spring Cup Competition. Initial competition began with valley wide play that culminates with the top teams advancing to a District Tournament against teams from Austin, San Antonio and Corpus. The first and second place finishers continue to a State Playoff featuring teams from the Houston area and El Paso.

By placing first place at state, Rio Valley's **Under 13 Pachuca USA** and **Under 16 Thunder United** 94 Boys teams from Brownsville will represent South Texas Youth Soccer Association at the **USYS Region III President's Cup Competition** in Broken Arrow, Oklahoma on June 10 - 13, 2010. The Region III Champions will qualify to advance into the National President's Cup Tournament in July.

This is Thunder United 94 second consecutive appearance at the 2009 Region III Tournament. Last year, Thunder United placed first at both the President's Cup Regional held in South Carolina and the National Tournament held in North Carolina.
